#### **IRS Free File Program delivered by TurboTax**

#### You qualify to use this product f you can answer "yes" to ONE of the following:

- Is your adjusted gross income \$36,000 or less?
  - What is AGI?
- Do you qualify for the Earned Income Credit?
  - Whats EIC?
- Are you active duty military (reserves, nation guard) and have an AGI of less than \$69,000?
  - What counts as active duty?

# **Sign In/Account Recovery**

If you have filed with IRS Free File Program delivered by TurboTax (formerly TurboTax Free File Program, or TurboTax Freedom Edition) but don't remember their username or password, you can use Account Recovery to reset it. From the Sign In screen click, "I forgot my User ID/Password" to start this process.

You can recover the account by using any of the following information associated with the account:

- User ID
- Email
- Phone Number

If you don't have access to the email or phone number on the account, no problem! You can create a new account.

- Basic info (Name, DOB, SSN, etc...)
- Filing Status
  - What filing status is right for me?
- Dependents- This can include children, grandchildren, parents, girl/boyfriends.
  - Who can I claim as a dependent?

Answer the questions on the screen and TurboTax will tell you what the best filing status is, and if you can claim dependents.

#### Income


You'll need to enter ALL income\* earned for 2019. This includes:

- ALL W-2s from employers ٠
- ALL income from contract work or their business, including cash payments (see next slide for more info on this)
- Any retirement income from Social Security, and 1099-R forms
- Any other forms you may have received in the mail ۲ or online

#### What if I'm missing a form?

If you are still waiting on a form in the mail, misplaced it, haven't received a W-2 form a previous employer you should not file until you have all of these forms.

You can login to your account later to add the missing form and then file.

\* Certain income isn't taxable and does not need to be included. Examples include SSI Disability income and child support.


#### Income

#### 1099-MISC/Business Income & Expenses

You may have a 1099-MISC for "nonemployee compensation" (Box 7) and/or get paid in cash. If this is the case the IRS considers you to have a business, and you'll need to file a Schedule C.

Enter **ALL** of the income associated with that job and **ALL** of the deductions (mileage, supplies, etc...)


### **Income: Over the AGI Limit**

If you enter all your income and you are over the AGI limit to qualify for this program, you will see a disqualification screen


If this occurs, you can:

- Recommended- Go to the <u>IRS Free File site</u> and look at other Free File options (including <u>VITA</u>)
- Transfer the account to a commercial TurboTax product. (See Appendix for instructions)




#### **Deductions & Credits**

Earned Income Tax Credit (EIC)

The Earned Income Credit is a great tax credit for working families. You can see if you qualify by navigating to the EIC topic. This is in the **Deductions & Credits** area under the **"You and Your Family"** section (see screenshot below)

- If you believe you qualify for Earned Income Credit, but the product says you do not qualify or received less than they expected:
  - Make sure the "My Info" section is accurate
  - Review the <u>EIC eligibility</u>




#### **Deductions & Credits**

Standard vs Itemized

Itemized deductions (charitable donations, medical expenses, mortgage insurance, property taxes) must add up to **MORE** than their Standard Deduction to be beneficial


Standard Deduction amounts for 2019:

- Single- \$12,200
- HOH-\$18,350
- MFJ- \$24,400
- Unless you have a mortgage or an extreme amount of Medical Expenses it is unlikely that you will see a change in your refund from entering these deductions
- States have different standard deduction amounts; you can still enter these deductions on your federal return and TurboTax will transfer them to your state return automatically



### **Other Common Sections**

- Health Insurance
  - If you have a **1095-A**, enter it in the **"Medical"** section of **Deductions & Credits**
  - If you received a 1095-B or 1095-C, or didn't have health insurance you don't need to enter any information
- 6-digit IP PIN
  - If you receive a 6-digit Identity Protection PIN from the IRS you must enter it in the **Other Tax** Situations section
- State Taxes
  - All appropriate Federal Info will be automatically transferred to their State Return



## **Refund/Balance Due**

- If you have a refund:
  - You can choose to have you Refund directly deposited into your bank account (Recommended!) or mailed via paper check.
- If you have a balance due:
  - If you owe tax on your Federal or State return you cab have the tax due debited out of your account or pay it via paper check.
  - You will receive all the necessary vouchers and mailing addresses when you print the return.




#### **Prior Year AGI**

As a security measure from the IRS, everyone must add their last year's AGI to their return in order e-file a return. If you do not have your prior year return available, you will need to print and mail the return.

Exceptions:

- You have a 5-digit "Self Select PIN" they you've used every year.
- You entered a 6-digit "IP PIN" you received from the IRS.
- You did not file a return last year.

**NOTE:** You CANNOT guess this number. If the Prior year AGI does not match what the IRS has on record the return will be rejected by the IRS




# Print a Copy of your returns

- When you see this → page.
   STOP.
- Be sure to print or save a copy of your federal and state returns!
- If you have to print and mail your returns, print TWO copies. One to mail in and one to keep for your records.



## TRANSMIT THE RETURN! (HOORAY! YOU DID IT!)

- If e-filing the return
  - The orange button officially sends the returns to the IRS and your state authority (if necessary)
- If mailing the returns
  - Read the mailing instructions carefully! You will have all the instructions printed out with the return
  - Your return isn't filed until the IRS and state authorities receive a copy in the mail
  - Don't delay! Get them in the mail before April 15<sup>th</sup>



## **After filing**

E-filing

Check your e-mail! You should receive an email that your returns were Accepted or Rejected by the IRS/State in 48-72 hours.

If your returns are Rejected, don't panic! Log back into your account and follow the instructions to fix and resubmit the returns.

If the returns are Accepted, the IRS still needs to process the return and approve the refund. Refunds are usually sent out within 21 days of being Accepted.

Print and Mail Once you mail in your return(s), they are processed in 4-6 weeks.

#### Should You Call the IRS?

Once your return has been Accepted, TurboTax cannot tell you where your refund is. The IRS issues most refunds in less than 21 days, although some require additional time. You should only call if it has been:

- 21 days or more since you e-filed
- 6 weeks or more since you mailed your return, or when
- "<u>Where's My Refund</u>" tells you to contact the IRS

## **Switching from IRS Free File to Commercial TTO**

Please review the eligibility criteria for IRS Free File Program delivered by TurboTax carefully. If you started preparing your return and realize that you don't qualify, you should go to the IRS Free File site and look at other IRS Free File options that may fit your situation.

If you want to switch your account to a commercial TurboTax product, you can do so without creating a new account.

- 1. Log out of the return (make you have the username and password nearby!)
- 2. Close your browser window, and open a new one, or go to Incognito mode
- 3. Go to https://turbotax.intuit.com/
- 4. Click on **Product & pricing** at the top, then "TurboTax" under "File online"
- 5. Choose the necessary commercial product for your situation and click "Start for Free"
- 6. Choose "Sign In" at the top right
- 7. Log in with the same account information

Eventually you will be prompted to confirm the change to a commercial TurboTax product.

REMINDER: Once you are in a commercial TurboTax product you may be prompted to upgrade or offered other products.
